GENERAL PENALTY

Where no penalty is prescribed for a violation of the provisions of any title, chapter, or section of the Ordinance Code of the Town of Langford, then any person or persons, firm or corporation violating such provisions of the Ordinance Code of the Town of Langford or failing to comply with any of the provisions thereof shall, upon conviction thereof, where no penalty of punishment is prescribed within the title, chapter, or section containing such provision be punished by a fine in a minimum amount of \$50.00 up to a maximum amount of \$10,000.00 or by imprisonment in the county jail for a period not exceeding 180 days, or by both such fine and imprisonment at the discretion of the court.
