- 2.) After approval of the license(s) has been granted, purchase malt beverages and/or liquor from SD licensed wholesaler or a Langford licensed retailer. (Must not purchase from any other source.)
- 3.) Acquire the license from the Town of Langford BEFORE the event. (All appropriate documentation must be signed by applicant and approved by Town prior to issuance of the license.)
- 4.) Finance Office will bill for license fee and liquor tax fee. If alcoholic beverages were purchased through a Langford licensed retailer, the liquor tax will be collected from them; if purchased through a wholesaler, applicant will be billed for the liquor tax.
- 5.) Pay all associated fees.

TERMS AND CONDITIONS FOR ACQUISITION OF TEMPORARY LIQUOR LICENSE(S)

WHEREAS, all liquor and/or malt beverages are to be sold and contained within the premises of **303 MAIN STREET, LANGFORD, South Dakota**, which is known as **LOTS 10-12, BLOCK 28, LANGFORD, MARSHALL COUNTY, SOUTH DAKOTA**.

WHEREAS, the temporary liquor license(s) shall be acquired BEFORE the event and are valid only during the previously approved time(s) and date(s) as set forth by the Board of Trustees of the Town of Langford.

WHEREAS, all liquor and/or malt beverages acquired for this event must be purchased ONLY directly from a *wholesaler OR from a Langford business which holds a permanent liquor license from the Town and may not be purchased from any other source.

WHEREAS, the temporary liquor license fee of \$25.00 per license shall be paid to the Town of Langford BEFORE the event.

WHEREAS, the Town of Langford must be provided with adequate time to publish Notice of Hearing and conduct the Hearing at their regularly scheduled monthly meeting of the Board of Trustees. If a special session is required due to lack of sufficient notice to the Town of Langford, the fee of \$500.00 shall be required, and must be paid to the Town of Langford BEFORE the event.

WHEREAS, the holder of the temporary liquor licenses agrees to pay to Town of Langford liquor tax fees and license fee (if applicable) within ten (10) days following the event, if liquor was purchased through a wholesaler.

WHEREAS, the holder of the temporary liquor license assumes all liabilities and responsibilities, and agrees to save harmless the Town of Langford from any claims, causes of action, rights, liens or claims of whatever kinds or nature which may occur during the preparation of the event being hosted, during the actual event being hosted, or during the clean-up and maintenance time following the event being hosted.

WHEREAS, if one or more of the above terms and conditions is not met and adhered to before the event, Town of Langford reserves the right to withhold a temporary license that was previously approved at a council meeting for such event.

WHEREAS, if one or more of the above terms and conditions is found to have not been met after the event was held, the Town of Langford reserves the right to withhold future temporary liquor licenses for future events.
